

# **Privacy Statement**

### Personal Data We Collect

Metrowest Building Services Ltd. collects data to operate effectively and provide you the best experiences with our products. You provide some of this data directly, such as when you create a Metrowest Building Services Ltd. Account.

Usage data. We collect data about how you and your device interact with Metrowest Building Services Ltd.

Content. We collect content of your files and communications when necessary to provide you with the products you use. We also collect the content of messages you send to us, such as feedback. When you contact us, such as for customer support, phone conversations or chat sessions with our representatives may be monitored and recorded.

# How We Use Personal Data

Metrowest Building Services Ltd. uses the data we collect for two basic purposes: (1) to operate our business and provide (including improving and personalizing) the products we offer, (2) to send communications, including promotional communications.

In carrying out these purposes, we combine data we collect to give you a more seamless, consistent and personalized experience.

#### Reasons We Share Personal Data

- 2. protect our customers, for example to prevent spam or attempts to defraud users of our products, or to help prevent the loss of life or serious injury of anyone; or
- 3. protect the rights or property of Metrowest Building Services Ltd., including enforcing the terms governing the use of the services.

# Where We Store and Process Personal Data

Personal data collected by Metrowest Building Services Ltd. may be stored and processed in Metrowest Building Services Ltd. or its affiliates, subsidiaries or service providers maintain facilities. We take steps to ensure that the data we collect under this privacy statement is processed according to the provisions of this statement and the requirements of applicable law wherever the data is located.

### Our Retention of Personal Data
